Laboratory Economics is offering a database of all 626 independent labs, 776 pain management physicians and 10,000+ other providers that perform definitive drug testing (G0480-G0483) and/or presumptive drug testing (80305-80307). The database includes annual Medicare Part B test volumes and allowed payments by test code for each provider. The database comes in easy-to-use and searchable Excel spreadsheets.
